## **False Report of Rape Situation-Swatting**

The Royal Oak Police Criminal Investigations Division is investigating the false report of a rape situation. The female caller was reporting to be repeatedly sexually assaulted by her father. The incident began on Sunday, March 1, 2020 at 10:22 p.m., when an unknown suspect stated, she didn't want the police to come to the address because her father had a gun and would shoot the police if they came to the door. She stated at a residence located in the 4500 block of Groveland.

Royal Oak officers responded to the area and discovered the house to be vacant and for sale. Officers confirmed no one was at the house and checked with nearby neighbors. Further information was developed indicating the reported crime was false.

The act of calling in a false police report, on this scale, is commonly referred to as "Swatting." Swatting is the act of tricking police agencies into dispatching emergency responders to an ongoing critical incident. The result of this activity is very disruptive to emergency services and the community. Filing a false police report of this nature is a felony, with a penalty of up to four (4) years in prison, a \$2000 fine, and repayment of the cost of the resources deployed to the handle the incident.

Royal Oak Criminal Investigation Division is investigating the incident.

Nearby agencies throughout the area, had similar swatting calls around the same time period.
