Defrauding an Innkeeper Arrest

On June 21, 2021, at approximately 10:30 p.m., officers were dispatched to Bar Louie located at 530 S. Main St. for a male subject in the business who failed to pay his bill the night prior. Management stated the subject hosted a party and left his identification along with his credit card to pay for the \$1,500.00 tab on June 20, 2021. Officers spoke with the manager who stated the credit card was declined. The subject returned to pick up his identification and credit card but was unable to pay for the bill.

The 32-year-old Royal Oak resident was arrested for Defrauding an Innkeeper.

Disorderly Conduct Arrest

On June 22, 2021, at approximately 4:30 p.m., officers were dispatched to Royal Oak Post Office located at 200 W. Second St. for a male subject in the business who was disorderly in the lobby. Postal employees stated the subject was denied a money order due to not having identification. The subject became upset and began yelling at the employees. He stated he was going to, "shoot the place up."

The 54-year-old Ferndale resident was advised on trespassing and was arrested for Disorderly Conduct.

On June 23, 2021, Scott Richard MacDonald was arraigned before the Honorable Magistrate Chisholm of the 44th District Court. MacDonald was charged with one (1) count of Disturbing the Peace, a 90-day misdemeanor and/or \$500.00 fine.

MacDonald was given a \$10,000 personal bond with bond conditions of no contact with the post office, no alcohol or marijuana use, and enter into Pretrial Services within 24 hours.
