Additional Incidents and Information

Operating Under the Influence of Alcohol 3rd Offense, Possession of Synthetic Narcotic, and Violation of Conditional Bond Arrest

On June 27, 2021, at approximately 11:30 p.m., Officers were dispatched to a single vehicle accident at Woodward and Hunter. The vehicle struck the curb of the median and hit several road signs. The officers spoke to the driver, and she smelled of intoxicants and slurred her speech. The driver admitted to drinking and was arrested. The driver also had two prior operating under the influence of alcohol arrests. The officers found several prescription pills not prescribed to her inside her purse. The driver had bond conditions from a prior domestic arrest, consisting of no alcohol or drug use.

The 49-year-old Royal Oak resident was arrested for Operating Under the Influence of Alcohol 3rd Offense, Possession of Synthetic Narcotics, and Violation of Conditional Bond.
